## **How we use Trustee, Member and Governor Information**

## We collect your information to:

- enable you to serve as a Trustee, Member or Governor
- comply with our statutory safeguarding obligations
- deliver appropriate training
- effectively manage the school
- fulfil statutory reporting to the Department for Education

#### The categories of school information that we process include

- Personal information (such as name, preferred title, date of birth, address, email address, telephone numbers, information about business and pecuniary interests)
- Characteristics information (such as gender, age, ethnic group, nationality, copies of right to work documentation, DBS details)
- Disability and access requirements

#### Why we collect and use Trustee, Member and Governor information

We only collect and use personal information about you when the law allows us to. Most commonly, we use it where we need to:

- Processing is necessary to comply with the legal obligations of the controller.
- Processing is necessary for tasks in the public interest or exercise of authority vested in the controller.

Less commonly, we may also use personal information about you where:

- You have given us consent to use it in a certain way.
- We need to protect the vital interests of the individual (or someone else's interests).

Where we have obtained consent, this consent can be withdrawn at any time. We will make this clear when we ask for consent and explain how to withdraw it.

# **Collecting Trustee, Member and Governor information**

We collect personal information via individual Trustees, Members and Governors.

Trustee / Member / Governor data is essential for the school's operational use. Whilst the majority of personal information you provide to us is mandatory, some of it is requested on a voluntary basis. In order to comply with GDPR, we will inform you at the point of collection, whether you are required to provide certain information to us or if you have a choice in this.

#### **Storing Trustee, Member and Governor information**

Any information about a Trustee, Member or Governing Board member is kept secure and is only used for purposes directly relevant to your term as a Trustee, Member or Governor at the school. Once your term(s) of office with us has ended, we will retain this file and delete the information in it in accordance with our retention policy.

## Whom we share Trustee, Member and Governor information with

We routinely share information with appropriate third parties, including:

- the Department for Education (DfE), to meet our legal obligations to share certain information with it
- Companies House, to meet our legal obligations as an academy
- the ESFA, to meet our legal obligations as an academy

- Stockport MBC, to meet our legal obligations to share certain information with it, such as safeguarding concerns
- Disclosure and Barring Service (DBS), to meet our legal obligations to share certain information with it
- Police forces, courts, tribunals
- Ofsted, to meet our legal obligations to share certain information with it
- Strictly Education, to enable them to provide the HR and Payroll services we have contracted them for
- Haines Watts, to enable them to provide the Accountancy services we have contracted them for
- Teachers2Parents, to enable them to provide the email- and text-messaging services we have contracted them for
- H Tempest Ltd, to enable them to provide the services we have contracted them for ie photographs for our staff/Governor ID badges, school photo board and website
- The Trust Governor, to enable them to provide the secure platform we have contracted them for
- GOVAS, to enable them to provide the Governor support services we have contracted them for
- NGA, to enable them to provide the Governor support services we have contracted them for
- Hi Impact who provide our school website, to meet our legal obligations to publish information about Trustees, Members and Governors
- InVentry, who provide our entry and exit system

#### Why we share Trustee, Member and Governor information

We do not share information about our Trustees, Members and Governors with anyone without consent unless the law and our policies allow us to do so.

# **Department for Education**

We share personal data with the Department for Education (DfE) on a statutory basis. Under s.538 of the Education Act 1996, and the Academies Financial Handbook, the Secretary of

State requires boards to provide certain details they hold about people involved in governance, as volunteered by individuals, and the information kept up to date.

### **Data collection requirements**

The DfE collects and processes personal data relating to those governing schools (including single and multi academy trusts (MATs)) and all schools are required to ensure they keep their governors details up to date under s.538 of the Education Act 1996, and the Academies Financial Handbook.

- claim compensation for damages caused by a breach of the Data Protection regulations
